History

The official date of the organization of Cummaquid Golf Club of Yarmouth and Barnstable was August 17, 1895, and history states, it was the first golf club in Barnstable County. Cummaquid sits on the South side of historic Rte. 6A in the towns of Cummaquid and Yarmouth Port. In late 1895, the small group of organizers managed to build the original 9 holes of the course. A description of that land was as follows: "The land, some of which was bought by the club, and some of which was rented at first and bought later was very rough and uncultivated with plenty of blackberry vines and the outlook for fairways and putting greens was not very promising. Different lots were enclosed by stone. Additional land was purchased and developed in the early 70's and became what it is today. The picturesque 18 hole course measures a little over 6355 yards from the tips. The course features lush fairways and true greens and the blackberry bushes still exist along many parts of the course today. The course is pretty much what you see is what you get with most shots clearly in front of you. The course does offer many elevation changes on both nines that create much diversity. The scenery in the fall rivals any New England course.

Membership

The membership has 350 active memberships consisting of 190 Singles and 160 families with a total membership over 650. The average age of the membership is 65, the club is member owned. The club has many active leagues playing throughout the golfing season with several mens Senior leagues, women's 9 & 18 hole leagues and two of our most popular events, Tuesday night Mens Mosquito League and a Thursday night Scotchball. Throughout the golf season there are multiple one day member guest tournaments for both men and women and several two day events and our ever popular three day mens member guest.

Revenues/ Charitable Outreach

Total revenues reach over 5 million dollars annually with just under a million coming from food and beverage. Cummaquid hosts many events through the year focusing on charitable organizations from around the Cape. The membership has a close connection to the community and is the proud sponsor of The Cummaquid Charity Tournament, many local charities have been benefited from the clubs generosity.

Dining Facilities

The new club house was completed in 2017 and has a great views from all areas inside of our 428 yard par 4 finishing hole, the first tee, practice green and irrigation pond.

It has been the gathering place for years to witness the most pivotal hole in many of the clubs events.

The Main dining room seats 110.

The Bar seats 14 with up to 60 additional seats in the bar area.

The covered outside deck seats another 40 members.

The club currently serves lunch daily and dinners Fridays and Saturday nights.

Dinner is also served on Tuesdays and Thursdays in season with our golf leagues.

The club also hosts a variety of events, including paired wine dinners, theme nights, chefs tables and many more including a 4th of July celebration and Women's Fashion Shows to name a few. The club is open 7 days a week for golf year round when weather permits and food-service is open from mid February (weather permitting) through December, closing January 1st upon completion of our Beef Stew Open.

About the Position

The General Manager/COO will be responsible for managing all operations of Cummaquid Golf Club consistent with the direction and policies established by the Board of Directors as well as by the By-laws and Rules and Regulations of the Club. The General Manager/COO is expected to essentially run the daily operations of the Club.

With the knowledge that the golf maintenance program and superintendent of the course are currently performing at very high levels, the next leader will guide the Board, staff, members, and community towards the future strategy for the Club to be the most desired Golf Club on Cape Cod.

About the Ideal Candidate

Ideally candidates should have 5+ years of experience with club/hospitality management positions leading up to a General Manager position at a similar culture organization with a professional career “track record” of achievement and relative employment stability.

He/she should have strong financial management, organizational and administrative skills, excellent people skills, and a high “emotional IQ,” with strategic planning experience.

The chosen candidate should have strong capital project management experience in anticipation of continuously upgrading our facility.

The selected candidate will have experience utilizing member relationships to develop offerings that enhance satisfaction and improve the value of the Club. He/she should also have proven leadership qualities with demonstrated ability to direct, train, and coordinate staff, and manage all facets of a highly regarded private club. The next GM/COO will also have a strong set of professional hospitality credentials and a sharp eye for detail. He/she must have excellent communication skills and experience in shaping social, dining, and cross-departmental programs with an understanding and appreciation of golf operations.
